## Senior Tournament Rules

### 1. ELIGIBILITY:

- A. Entrant must be 50 years of age or older on or prior to tournament opening date.
- B. Entrant must be a female with current membership with USBC, and a local association within the jurisdiction of the WS USBC. Association membership will be available for \$13.00 plus local association dues.

### 2. FORMAT:

- A. This is a handicap tournament consisting of doubles, singles and optional all-events. Handicap will be 100% of 235 base score.
- B. **Bowlers will bowl 5 games. The third game of Doubles will also count as the first game of Singles.**
- C. Bowlers entering doubles must also enter singles event, and vice versa. Singles event will follow doubles event.
- D. Doubles and Singles will be bowled on the same pair of lanes.
- E. Singles & All Events divisions:
  - Division 1.....75 & up
  - Division 2.....70 - 74
  - Division 3.....65 - 69
  - Division 4.....60 - 64
  - Division 5.....55 - 59
  - Division 6.....50 - 54
- F. Doubles event is one division. Doubles partners do not need to be in the same age division.

### 3. AVERAGE REQUIREMENTS: (Please read carefully)

Entrants shall use their highest USBC average in the following order:

- A. 2017-18 season, for 21 games or more,
- OR:**
- B. 2016-17 (previous year) winter average for 21 games or more, **OR:**
  - C. Current average of at least 12 games in a USBC certified league, as of the first date of tournament participation and verification form is provided, **OR:**
  - D. If none of the above applies, entrant will be permitted to bowl using scratch figure of 235.
  - E. USBC Rules 319a-2, 319d and 319e do not apply (Average adjustments) If Sport bowling average is the only average available; entrant will abide by the average adjustment scale of current USBC Rule book. The tournament manager has the right to adjust any sport/challenge league average.

### 4. AVERAGE/AGE VERIFICATION:

Each entrant is responsible for the accuracy of her age and average, whether submitted by captain or others.

- A. Failure to use correct age will result in disqualification.
- B. Failure to use the correct average shall disqualify score if submitted average is lower than correct average,

thereby resulting in more handicap. Prize winnings will be based on submitted average if it is higher than the correct average.

### 5. FEES:

- A. Entries must be accompanied with total fees.
- B. Entry fee will be \$20 per event, per bowler. Optional all events fee is \$5.00 per bowler.

### 6. RESERVATIONS:

- A. Reservations open first Monday of April.
- B. Entries and fees for reservations made April through August 19 are due by September 1.
- C. Entries and fees for reservations made after September 1 must be received within two weeks of reservation.
- D. Entries will be accepted until final week of tournament, based on availability.

### 7. CANCELLATION AND REFUND POLICY:

- A. Requests for refunds must be in writing from the team captain and received by the Tournament Manager no later than one day prior to the opening of the tournament.
- B. Overpayments of \$5 or less will not be refunded.

### 8. SUBSTITUTES:

- A. Any bowler may participate one additional time as a sub in doubles event.
- B. Bowlers first doubles event bowled shall count towards her all events score.
- C. Entrants will be allowed to bowl only once in Singles Event.

### 9. AWARDS/PRIZE MONEY:

- A. Prize money will be returned 100%, on a ratio of at least one prize per every five entries.
- B. In case of a tie in any event, co-champions will be declared.
- C. All Events winner in each division are eligible to participate in the USBC National Senior Tournament. WISCONSIN STATE USBC will pay the entry fee.

### 10. SMOKING/FOOD/BEVERAGES:

- A. Smoking and electronic cigarettes will not be allowed in or outside the bowling center during competition and will be cause for disqualification.
- B. No food or beverage will be allowed in the settee or playing area.

### 11. RULES OF GOVERNANCE:

- A. The WISCONSIN STATE USBC Association Manager serves as Tournament Manager.
- B. The tournament is under the management of the WS USBC Board of Directors which has the power to hear and act on disputes, complaints or protests relating to the tournament. The decision of the Board is final except when an appeal is made to USBC.
