HALL OF FAME REQUIREMENTS

SKILLED, MERITORIOUS AND EXEMPLARY SERVICE

HALL OF FAME MISSION STATEMENT

Those selected for induction into the Wisconsin State USBC Bowling Association Hall of Fame are being recognized for their many accomplishments in and/or for the game of bowling.

PRE-REQUISITES FOR MEMBERSHIP

The following requisites are mandatory for nominees in the Hall of Fame.

1. Active participation in sanctioned bowling in the Annual Wisconsin State USBC Bowling Championships for a period not less than twenty (20) years.
2. Minimum eligible age, 50 years from date of birth.

State titles and top five finishes will also be taken into consideration for induction into the **Skilled** division. This does not include Senior titles.

BOWLERS SHALL BE SELECTED IN ONE OF THE FOLLOWING CATEGORIES

SKILLED

Bowling skill, repute, sportsmanship and winning of either state, local (your association) or National USBC/ABC Open Championship competition. Please include other Tournaments i.e. Non-pro, MAST, WSBT, State Match Play, etc.

MERITORIOUS

Distinguished service over a period of years in promotion of the game of American Ten-Pins and the Wisconsin State USBC Championship Tournament. This requires a special dedication to the progress, welfare and repute of their local association and its affiliated organization, above and beyond the call of duty.

APPLICATION

Application may be submitted by anyone with specific knowledge of the duly qualified nominee in writing to the Hall of Fame Committee by the application deadline.

DEADLINE

All applications must be in this office for evaluation for the next induction by May 1st of the current year.
